# President's Report: November 2015 to December 2016

Over the past year your Committee has undertaken a large number of tasks to capitalise on a range of new opportunities and challenges. Organisation of our Annual Meetings is always a major focus of activity for the Society. Our success in attracting ISSCR 2018 to Australia required us to bring forward the 2017 Annual Meeting to May 2017. As a result, this year your Committee has organised two ASSCR Annual Meetings in parallel (2016, 2017), and also progressed the 2018 ISSCR conference. As described below, to provide similar numbers of conference travel awards as previous years the 2016 and 2017 ASSCR meetings have been organised with minimal external logistical support. At the same time the Committee has pursued important community and policy interactions, and also further refined the Society's operations in-line with our updated Rules.

As announced at the 2015 Annual General Meeting, one new member was elected to the 2015/2016 ASSCR Committee, and the Committee consisted of:

## 2015 Joint ASSCR/SCA/NSW SCN Conference

Our 8<sup>th</sup> ASSCR Annual Meeting, jointly held with Stem Cells Australia and the NSW Stem Cell Network, took place 8–10 November, 2015, in the Hunter Valley. It was attended by over 290 delegates, with 7 international invited speakers, 58 oral presentations and over 120 posters. Conference sessions included pluripotency, differentiation, bioengineering, clinical translation, stem cell commercialisation, as well as stem cell ethics and legislation.

The meeting also included the <u>launch of the journal Regenerative Medicine</u>, an exciting collaboration between Monash University and the Nature Publishing Group. As described in the Treasurer's Report, the meeting was also a great financial success, with a significant surplus going to all 3 joint partner societies. Our sincere thanks go to <u>all our meeting sponsors and exhibitors</u> whose continued valuable support helps make our meetings possible. Continued funding from the National Stem Cell Foundation of Australia (NSCFA), together with additional funds from the ASSCR, enabled 62 postgraduate students and postdocs to attend the meeting. These travel awards provide invaluable presentation and networking experience for our trainee members, and also greatly increase the vibrancy of our meetings by enabling large numbers of our trainee members to participate.

#### Organisation of the 2016 and 2017 ASSCR Conferences and 2018 ISSCR Meeting

The exciting announcement of Melbourne as the ISSCR Annual Meeting location (20–23 June 2018) represents a strong endorsement of the stem cell community in our region.

Organisation for 2018 is already underway with our incoming President, Prof. Melissa Little, accepting an invitation to lead the Scientific Program Committee for the meeting. The main organisational efforts currently being led by the ASSCR for the 2018 meeting include liaising with the 27 pledging institutions to receive and hold pledged funds, and preparation for the public forum to coincide with the 2018 ISSCR meeting.



To best prepare for the mid-year timing of the 2018 ISSCR meeting, the ASSCR Committee decided to alter the timing of both the 2016 and 2017 ASSCR Annual Meetings.

Moving our 2016 Meeting from November to December enabled a joint meeting with the Centre for Cell Therapy & Regenerative Medicine, to be held from 4–7 December at the Pullman Resort, Bunker Bay, Western Australia. This will be the first ASSCR meeting held in Western Australia and provides a timely opportunity for closer interaction and strengthened ties with our colleagues there. The thought-provoking program and stunning location promise a stimulating meeting.

In 2017 our Annual Meeting will be moved forward to 24–26 May to enable us to partner with the Australasian Gene and Cell Therapy Society meeting. Given the growing national and international alignment between cell and gene therapy this represents a unique opportunity to increase interactions between our societies.

#### Strategy for Maintaining Large Numbers of ASSCR Conference Travel Awards

Alongside these exciting joint conference opportunities there have been a number of challenges. The most significant of these has been a decrease in travel award funding received from the NSCFA from \$50,000 per year for each of the 2013 and 2014 conferences (that enabling over 120 travel awards to be provided). Changes in the fiscal environment saw this funding reduced to \$35,000 for the 2015 conference, and \$10,000 for each of the 2016 and 2017 conferences.

The Society greatly appreciates continued NSCFA support at whatever level possible. Nevertheless, this large reduction in conference funding necessitated development of a new travel award funding strategy. The Committee has therefore pursued two approaches to enable use of Society funds in order to offer similar numbers of travel awards for the 2015 to 2017 conferences. These approaches are: i) holding joint conferences with appropriate societies to share the financial risk; and ii) coordinated use of the Subcommittee Chairs to streamline the Society's reliance on contracted logistical support for conference organisation, and thus maximise conference revenue to provide travel award funding for future conferences.

These two approaches enabled the ASSCR to fund 42 of 62 and 23 of 38 Travel Awards for the 2015 and 2016 conferences respectively (including 2 international travel awards each year), with the remaining travel awards supported by NSCFA funding. Importantly, the travel awards were funded while still achieving strong growth in ASSCR cash reserves. Continuation of this strategy in 2017 and beyond will place the Society in a strong position to maintain vibrant annual meetings through large numbers of travel grants while keeping sufficient cash reserves for the Society.

#### ASSCR Public Engagement via State-Based Events and the Stem Cell Stories Exhibition

In 2015 the ASSCR underwent a brand development process that crystallised the core Society messages currently driving our various initiatives. The ASSCR stands for: *Rigor; Accuracy; Professionalism; Trustworthiness; Approachability*, and our public engagement should *Inspire, Inform and Empower* patients to make informed health choices by providing access to reliable information. These messages are at the core of our ongoing public engagement activities such as the Stem Cell Stories multimedia exhibition, State-based public Q&A stem cell events, and organisation of the 2018 Public Forum that will coincide with the 2018 ISSCR meeting in Melbourne.

The Stem Cell Stories multimedia exhibition continues to stimulate interest within the general population and media. It now consists of colour posters, <u>a 10 minute video</u> and <u>mobile website</u> for general information on stem cells and stem cell tourism, So far ~1 million people have viewed the exhibition in person at Questacon (Canberra, 2013–15), the Royal Institute of Australia (Adelaide, 2014), SciTech (Perth, 2015) or through associated print and TV media including the ABC 7:30 Report Adelaide (2014) and <u>Cosmos magazine</u> (December 2014).

Additional public interactions we have pursued include: i) state-based public/professional stemcell information events led by Margret Schuller; ii) Society submissions to the 2016 TGA public consultation on use of autologous cells and tissues; and iii) participation in the development and launch of an Australian Academy of Science report that discusses the future of the Australian stem cell industry (The Stem Cell Revolution: Lessons and Imperatives for Australia).

#### **ASSCR Finances**

As described in the Treasurer's Report, the Society is solvent and in a healthy financial condition. In keeping with previous years, revenue reported under the Society ABN for the 2015–16 financial year is below \$250,000 and thus the Society remains a small society as defined by the Australian Charities and Not-for-Profits Commission. To our knowledge the financial statements presented here, prepared in consultation with the ASN Events financial officer, provide a true and accurate description of the Society's finances. Through the success of our 2015 joint meeting in the Hunter Valley our cash reserves have increased well, placing the Society in a good position to meet the challenges of the next 2 years, including the Society's current and future liabilities.

#### **Improving Committee Position Descriptions, Timelines and Handover Documents**

The Committee has continued evolving position descriptions and timelines to clarify roles and to improve information transfer to new Committee and Subcommittees members. In particular, these efforts have enabled the Committee and Subcommittees to integrate their activities in order to achieve the new travel award funding strategy described above. This information should prove highly useful to future Committees and should enable continuation of this strategy beyond 2018.

#### **2016** Committee Election Process

This year nominations were called for 4 elected Committee positions: the Vice President position and three Ordinary Committee positions (Policy, Ethics and Translation Subcommittee Chair; Conference and Awards Subcommittee Chair; and Junior Investigator Subcommittee Chair). Single valid nominations were received for the three Ordinary Committee positions. Therefore, as per ASSCR rules no election will be held for these positions. An online ballot is being held for the two nominations received for the Vice President position. The results of the election processes will be announced at the 2016 Annual General Meeting to be held 1–2 pm on 6 December.



#### Summary

The ASSCR is continuing to mature as the leading regional professional organisation for researchers, clinicians and industry representatives working in the stem cells and regenerative medicine field. Strategies aimed at increasing our member base – such as hosting our first WA-based conference, joint meetings with other societies, and maintaining large numbers of conference travel awards – are helping to continue growth of the Society in the lead-up to the 2018 ISSCR meeting in Melbourne, despite financial challenges.

I have enjoyed contributing to ASSCR activities and the extensive evolution of the Society over the past 6 years as Secretary, Vice President and President. Throughout the next few years the Society will have strong and expert leadership provided by our in-coming President, Prof. Melissa Little. In addition to our annual meetings, opportunities and challenges for future Committees will likely revolve around updating the Society website and expanding the impact of our newsletters.

On behalf of myself and the Society's membership I thank the Committee members for their efforts of the past year. We are excited by the opportunities the next few years hold and we look forward to seeing you at our coming meetings.

## ASSCR Committee Meeting Dates and Attendance (July 2015–November 2016)

This has been the first full year of the Society's new Committee structure. Under this structure, the 9-member Committee has held 10 meetings. In addition, there was frequent email communication throughout the year on matters including:

(i) Continued preparation for the bid, and contract finalization, for the successful bid for 2018 ISSCR Conference. The Society has set up, with the help of ASN Events, a process for receiving pledges from pledging institutions and investing them in a term deposit prior to transfer to the ISSCR.

(ii) The Society is also investing some of its other capital in a separate term deposit. Money raised from these investments will go to support various activities, including Travel Awards for local and international postgraduates and ECRs.

(ii) Preparing for our 3<sup>rd</sup> joint Annual Meeting (with the Centre for Cell Therapy and Regenerative Medicine). In addition, our Annual Meeting for 2017, to be jointly held with the Australasian Gene and Cell Therapy Society, has been brought forward to May and preparations are well underway.

(iii) Negotiating Postgraduate and Early Career Researcher Travel Awards with the NSCFA. The NSCFA has pledged funds for both the 2016 and 2017 meeting.

(iv) Continued improvement to the new website with an expansion of the content of the eNewsletters, and the opening of our new Twitter account (@theASSCR).

(v) Taking the Stem Cell Stories travelling exhibition to SciTech in Perth, and participation in the Theo Murphy Thinktank forum on The Stem Cell Revolution (July 2015).

(vi) Making submission to the second TGA call for potential changes in regulations relating to autologous stem-cell procedures (October 2016).

(vii) Policies have been developed to respond to public enquiries and to assess Membership applications.

(viii) A registry is being developed of companies, clinicians and researchers working in the field of stem cells and regenerative medicine in the broadest context.

## **Reports on ASSCR Activities**

# **8<sup>th</sup> Annual 2015 Meeting – Joint ASSCR/SCA/NSW SCN Conference,** 8–10 November 2015, Hunter Valley, NSW

This was the Society's 2<sup>nd</sup> joint meeting. An excellent program was developed by Jeremy Crook (ASSCR) supported by the Organising Committee. 7 international speakers were invited, with the Keynote Presentation delivered by esteemed stem-cell researcher Dr Mahendra Rao (Vice President for Regenerative Medicine at The New York Stem Cell Foundation Research Institute, and former Director of the National Institutes of Health Center for Regenerative Medicine). His presentation was followed by an inspiring presentation by Patient Advocate Adam Johnston. 6 invited national speakers also contributed to the program.

The conference featured 3 Plenary Sessions (Basic Biology of Pluripotent Stem Cells & Differentiation, Stem Cells and Clinical Translation, and Disease Modelling) and several Concurrent Sessions (Bioengineering Tissues, Ethics and Legal, Stem & Derivative Cell Epigenetics, Neural Stem Cells and Development, Stem Cell Companies – More than One Way to Get to the Market Place, plus a number of Mixed Theme sessions)

We again ran a Corporate Breakfast Session, on organoid culture and clinical models, which was extremely well attended (sponsored by Lonza and PeproTech).

We congratulate the 5 postgraduate/ECR winners of our Oral and Poster Prizes (\$500 each) for their outstanding efforts:

Poster Award – PhD: Sarah Hemming Poster Award – ECR: Martin Engel Oral Award – PhD: Lizhe Zhuan Oral Awards – ECR: Jessica Frith and Christian Nefgzer

There were 120 posters from postgraduates and ECRs and the authors of 6 of the top scoring posters gave a 5 min oral presentation of their work in the Best of the Best Poster Presentations session.

The ASSCR also congratulates all winners of the postgraduate/ECR Travel Awards sponsored by the NSCFA and the ASSCR and the winners of the International Travel Awards sponsored by the ASSCR.

In keeping with the ASSCR's support for students and early career researchers, Junior Investigator events included a dinner and lunchtime forum with panel discussions about career development, innovation and entrepreneurship.

The total amount raised from sponsorship, trade and advertising was over \$170,000. Special mention goes to the efforts of Margret Schuller (ASSCR) and her team for their part in raising this record-breaking amount.

#### Submissions to the TGA on the regulation of autologous stem cell procedures

In March 2015, the ASSCR, under the leadership of the Policy, Ethics and Translations subcommittee, submitted its views to the TGA on potential changes to policy and practice regarding this contentious and, at present, less stringently regulated, clinical field. Our submission recommended tightening of controls in several key areas. The full report, along with those of similar Australian societies and networks, and various individuals can be found <u>here</u>.

In August 2016, the TGA announced a second round of consultation: <u>Regulation of Autologous</u> Cell and Tissue Products and Proposed Consequential Changes to the Classification of Biologicals

The ASSCR again made a submission maintaining a strong and consistent position on this issue. The timing of this second round was particularly relevant in light of the recent NSW Coroner's Inquest into a <u>"Surgical case – "Experimental" therapy for dementia</u>", as <u>commented on</u> by the ASSCR.

#### State-Based ASSCR Public/Professional Events

Since July 2015, Margret Schuller and her team have organised three highly successful Hot Topic Q&A events. This is the first time the ASSCR has run additional conferences and it has become an important part of our outreach program. All events were free to scientists, clinicians and the public and run at no cost to the ASSCR. The events featured panel members drawn from across Australia. The events were:

*1. Stakeholders' perspective on autologous stem cell therapy regulation* (1 July, 2015, 6–8 pm, Genea headquarters, Sydney; refreshments provided by Eppendorf and Miltenyi Biotec)

*Panel members:* Prof. Stephanie Watson (Clinician and Researcher), Dr Russell Vickers (Clinician), Prof. Richard Harvey (Researcher), Prof. Bernie Tuch (Clinician and Researcher), and Dr Peter Harman (15 years' experience working with the TGA on regulation of the In-Vitro Diagnostics industry).

This event attracted 80 participants and was timely given the TGA's consultation process on potential changes to regulation in this sector. Freelance science writer and broadcaster Leigh Dayton subsequently summarised the evening's discussion with Tony Delroy on the local ABC radio science show. The ASSCR formally submitted its views to the TGA on 3 March 2015.

2. Australian stem cell industry business model (1 September, 2015, 6–8 pm, Genea headquarters, Sydney; refreshments provided by In Vitro Diagnostics and ThermoFisher).

This event attracted 50 participants and lively discussion ensued focussing on:

- How to strengthen relationships between private industry and universities in order to foster innovation.
- How to reverse the trend of stem-cell and related companies leaving Australia to relocate overseas.
- Establishing a national business plan for the stem-cell industry, which includes helping to guide legislation and regulation, and improve funding.

3. Advancing Stem Cell Therapies: Balancing science, clinical trials, regulation and consumer demand (31 May, 2016, 6–8 pm, Victor Chang Cardiac Research Institute; Level 4; refreshments provided by LONZA and bioMerieux)

The event attracted 60 participants and focussed on a number of key areas:

- The pros, cons, expectations and realities surrounding the use of stem cells for cellular therapies.
- Challenges of commercial versus research-based stem-cell clinical trials.
- Innovation through clinical practice (and possible exploitation of patents) versus the clinical trial process.
- Recently enacted Japanese legislation for accelerating stem-cell products to market.
- Transparency of trial results to Government and regulating authorities.

## Membership and Website

The Communications and Membership subcommittee has continued the process of updating and expanding the new website with relevant content. Our new Twitter account (@theASSCR) went live in February 2016, and together with the changes to the website has significantly improved dissemination of information to Members and the wider stem-cell community. News on the website and Twitter feed included scientific breakthroughs, stem-cell news from around Australia and internationally, notification of stem-cell related conferences and events, as well as meeting reports.


ASN Events has been contracted for a third 2-year period (starting July 2016) to process ASSCR membership payments and renewals. This outsourcing allows volunteers to focus on issues relating to enhancing and expanding the reach of the Society and providing better service and opportunities to its Members. In a significant change, however, the ASSCR is partnering with its



joint-meeting societies in 2016 and 2017 to run the Annual Meetings largely without input from ASN Events. The anticipated savings should help to keep meeting registration costs low, provide Travel Awards to postgraduates and ECRs as the gratefully received NSCFA sponsorship diminishes, and support additional ASSCR-sponsored events.

As of 30 June 2016, the ASSCR has 226 financial members, the same as last year but an increase of 20 members since 2014 and up from 169 in 2013 and 89 in 2012. The graph below shows the geographic distribution of our Members.

The ASSCR is continuing the process of generating an Australasian database of stem-cell researchers, clinicians and businesses with a view to boosting membership further and improving communication.

# Treasurer's Report, Financial Year 2015–16

The Australasian Society for Stem Cell Research (ASSCR) is incorporated in Victoria PC 3194 (ABN:45 374 899 784) and registered as a tax-exempt not-for-profit charitable organisation. As a Charitable Institution the Society is endorsed to access the following tax concessions: GST Concession 18 Apr 2008; Income Tax Exemption (since 18 Apr 2008); and FBT Rebate (since 18 Apr 2008). The ASSCR is also endorsed as a Deductible Gift Recipient (since 18 Apr 2008).

The ASSCR is in a strong financial position with current net assets of \$139,274; an increase of \$51,569 (59%) in the past 12 months. These cash reserves are more than sufficient to offset \$46,000 in anticipated liabilities for 2016 through 2018 (page 17), leaving uncommitted cash reserves of approximately \$93,000. The NSCFA have informed us their historically high level of support for travel awards will not be continued at least in the short-term. The ASSCR is committed to enabling large numbers of young investigators/students to attend our Annual Meeting so, as outlined above, a strategy has been implemented to maximise use of ASSCR conference income to support provision of travel awards.

Most aspects of ASSCR Annual Meetings from 2008 to 2015 were at least partially managed by ASN Events, with the exception of abstract and travel award ranking. In 2012 the Society signed a memorandum of understanding (MOU) with ASN for secretariat services, and this was renewed in 2014 and again in 2016 (with an added option of outsourcing conference organisation to other parties if/when required by conference partner societies). Through these MOUs cash flows associated with membership fees, conferences and other activities have been managed by ASN - via an operating account held at National Australia Bank (NAB). The ASSCR Committee members are not signatories to this account; instead the Treasurer and ASSCR President authorize the ASN Financial Controller to make and receive payments on behalf of the Society.

An additional consequence of the MOUs is that all transactions processed via ASN are reported to the Australian Taxation Office (ATO) by ASN Conferences acting as agent, and all GST liabilities are remitted by ASN Conferences on submission of the ASN Conferences Business Activity Statements (BAS). Currently all GST reporting occurs under the ASN Events' ABN; moreover ASSCR currently submits 'nil GST returns' to the ATO with respect to its own ABN (as currently no transactions occur outside of the ASN-operated NAB account). ASN now provides the ASSCR with a quarterly tax liability summary as well as a full GST ledger annually for our records.

Other ASSCR cash flows have been managed through a Bankwest business account but this has been inactive since 2013. The remaining funds in this account (\$17,665.40) will be either dispersed as 2016/2017 travel awards (see below) or incorporated into a term deposit investment strategy, initiated in 2016 by transfer of \$60,000 into a high interest term deposit account.

Income this financial year was generated by a combination of membership fees, profit share from the 2015 Annual Meeting, sponsorship from SCA and NSCFA for public engagement projects and promotional activities, and interest earned on our NAB bank account. Expenditures this financial year were on the 2015 Annual Meeting, ASN management and administrative fees, website and committee meetings, support for promotional and stem cell outreach events including the Illuminart public engagement project, and presentation prizes awarded at the 2015 CCTRM Research Symposium (see the notes to Table 2 for more details).



Breakdowns of Income and Expenditure as well as Net Equity for each year from 2013 to 2016 are provided in Tables 1–2 for comparison purposes. A brief summary of our financial position as of 30 June 2016 (including financial summary of the 2015 Annual Meeting) is given below.

## **ASSCR Net Equity:**

As of 30 June 2016, our net equity was \$139,274.15. This sum included: \$17,665.40 in our Bankwest account \$121,608.75 in our ASN managed NAB operating account

#### 2018 ISSCR meeting pledges

As of 30 June 2016, ASSCR also held \$57,500 in pledges for the 2018 ISSCR meeting in a subaccount of our ASN-NAB account; these funds are not included in the Net Equity above.

#### Payment of overdue GST

As summarized in the 2015 Annual report, ASSCR had overdue GST in the amount of \$1,561.00 owing to the ATO in 2015–16 financial year. This was paid on 12/10/2015.

ASSCR Income in the 2015–16 financial year (independent of the 2015 Annual Meeting) came from memberships, interest on our operating account, and sponsorship from NSCFA/SCA to support the promotional and public engagement projects. \*The 2015 meeting generated sufficient surplus that the seed fund return could be categorised as retained profit rather than income earned in this FY.

ASSCR expenses in the 2015–16 financial year (independent of the 2015 Annual Meeting) were secretariat and administration fees, web site maintenance, committee phone meetings, support for a Q&A Hot Topic event on stem cells, student/junior investigator presentation prizes for the 2015 CCTRM (UHU) Research Symposium at UWA, and support for the Illuminart Stem Cell public engagement project.

The full Treasurer's Report appears in the Annual Report. **4.** Treasurer's Report, 2014–15 **Current financial position** Financial Year • ASSCR has \$88k spread over 2 accounts \$17,665.40 in our Bankwest account; \$70,039.76 in the ASN-(Robyn Meech) managed NAB operating account. • ASSCR's financial position has improved steadily from 2012 to now (see Table 3 in Annual Report). • The 2014 Annual Meeting held in Lorne in conjunction with ISCT-ANZ and SCA produced a profit of \$28k divided between ASSCR and ISCT by mutually approved formula: \$17.5k came to ASSCR. • The projected profit for the current joint Annual Meeting with SCA and NSW Stem Cell Network is  $\sim$ \$32k, to be shared between the organising entities. • The table at the end of the minutes shows the profits to ASSCR from the last 3 meetings. • The Treasurer notes that not every meeting going forward will necessarily make a profit. The ASSCR Executive's outlook is not necessarily to make a profit on each meeting but to keep the ASSCR in a robust financial position.

- With the successful bid to host the 2018 ISSCR meeting in Melbourne, the ASSCR has pledged \$20k in support.
  - \$20k is also being earmarked for moving to an investment account. The interest will be used to support various activities such as Travel Awards.

#### GST accounting and remedying lapsed annual business activity statement reporting:

- As a GST registered entity with an Australian Business Number (ABN) number, the ASSCR is obligated to submit annual GST returns to the ATO. In August this year we became aware that reminders from the ATO to submit annual GST returns were not being received by the ASSCR Treasurer or Secretariat because the ATO had an out-dated postal address for the Society. As a consequence, there had been a lapse in submission of annual activity statements from July 2009 (including notification of those GST returns for this period not processed by ASN Events). This has resulted in overdue returns for the period spanning 1/7/2009 to 30/6/2014, in addition to the requirement to submit a return for the current financial year (1/7/2014 to 30/6/2015).
- The President and Treasurer undertook to rectify this situation immediately with the assistance of our secretariat, ASN Events, and specifically the services of the ASN Chief Financial Controller, Kerrie Harris-Spencer.
- As there had been no ASSCR business transacted outside of the ASN-managed NAB account since mid-2012, ASSCR was eligible to submit 'nil GST returns' for the period 1/7/2012-30/6/2015.
- Financial records for the period 1/7/2009 to 30/6/2012 were collated and examined by Ms Harris-Spencer, allowing her to submit the outstanding GST returns for this period. The result being that the ASSCR paid \$1,561.00 in overdue GST to the ATO on 12/10/2015; this will appear in the 2015/2016 financial statements.
- ASSCR's contact address with ATO is now ASN's address, which will pass onto ASSCR all relevant information.
- An application has been lodged with the ATO to have any fines for failing to submit annual GST reports to be rescinded.
