# President's Report: July 2016 to December 2017

As President of the Society, I am pleased to be able to present to you this Annual Report for 2016–2017. Over the past year your Committee has undertaken a large number of tasks to capitalise on a range of new opportunities and challenges. Organisation of our Annual Meetings is always a major focus of activity for the Society. Our success in attracting ISSCR 2018 to Australia required us to bring forward the 2017 Annual Meeting to May 2017. As a result, this year your Committee has organised two ASSCR Annual Meetings in parallel (2016, 2017), and also progressed the 2018 ISSCR conference. These are major achievements for the Society and have represented significant commitment from the Executive and Ordinary committee members of the Society. The meeting in December 2016 was a joint meeting held in Western Australia in association with the CCTRM. The 2017 meeting was a joint meeting with the Australasian Society for Cell and Gene Therapy held in Sydney. This highly successful meeting facilitated growing interactions between the stem cell and gene therapy disciplines. Both Societies found the combined scientific program to be very strong and there is considerable enthusiasm to have joint meetings between these two societies in the future.

ISSCR 2018 is to be held in Melbourne from 20-23 June. Planning for ISSCR has represented a large amount of effort on behalf of individual committee members. ASSCR is very pleased to be hosting this meeting and have been working closely with the ISSCR to plan several key associated events, including a public forum and a clinical translation forum, both prior to the formal meeting. A number of Australian researchers have been invited to present on the program and we will have a fabulous international line-up, including Doug Melton, Jennifer Doudna and Katherine High.

As described below, to provide similar numbers of conference Travel Awards as previous years the 2016 and 2017 ASSCR meetings have been organised with minimal external logistical support. At the same time the Committee has pursued important community and policy interactions, and also further refined the Society's operations in-line with our updated Rules. ASSCR is also working with NSCFA to deliver travel support to student members wishing to attend the ISSCR meeting in June.

#### Overview of ASSCR Committee and Subcommittee Activities for 2016–17

- i) Organising and holding the joint 2016 and 2017 ASSCR Annual Meetings both meetings were held without the help of a Professional Conference Organiser.
  - Conference sponsor drive led by the Sponsorship and Industry Subcommittee Chair
  - Abstract/travel award organisation led by the Conference and Awards Subcommittee and Treasurer
- ii) Organising for the 2018 ISSCR Conference, including handling sponsorship pledges, and organising the public forum in terms of its scope, audience, display of the Stem Cell Stories Exhibition.
- iii) Holding another state-based public event as part of Science Week led by the Sponsorship and Industry Subcommittee Chair.
- iv) Reporting on ethical, legal and social issues led by the Policy, Ethics and Translation Subcommittee, including: submission to the 2<sup>nd</sup> TGA public consultation on autologous cells and tissues in November 2016, which has contributed to a major revision of the rules governing the use of autologous stem cell procedures by the TGA in October this year.
- v) Management of Society finances led by the Treasurer, including investment of funds.
- vi) Continued implementation of the Society Rules (e.g., updating position descriptions and formalising assessment and approval of membership application.)
- vii) Creation of the 2017 Annual Report and organisation of the 2017 ASSCR Committee election.

# 2016 Joint 9th ASSCR Annual Meeting and 6th Margaret River Region Forum

Moving our 2016 Meeting from November to December enabled a joint meeting with the Centre for Cell Therapy & Regenerative Medicine to be held from 4–7 December at the Pullman Resort, Bunker Bay, Western Australia. This was the first ASSCR meeting held in Western Australia and provided a timely opportunity for closer interaction and strengthened ties with our colleagues there. The thought-provoking program and stunning location made for a stimulating meeting.

The theme of the meeting, Stem Cells – Fundamental Biology and Clinical Translation, featured sessions on genome organisation, epigenetics, single-cell studies, bioengineering associated with matrices and scaffolds, the genetics of disease, as well as immune- and organ-based therapies. A clinical session onDefining the Boundaries of Clinical Practice in Stem Cell Therapy was also held.

139 delegates attended the Meeting, with 4 international invited speakers, 58 oral presentations and 40 posters.

# 2017 Joint 10<sup>th</sup> ASSCR/AGCTS Conference

Our 10<sup>th</sup> ASSCR Annual Meeting was jointly held with the Australasian Gene and Cell Therapy Society (AGCTS) and took place on 24–26 May 2017 at the University of Technology, Sydney. Titled Accelerating Personalised Medicine: Stem Cells, Gene and Cell Therapy. This was an opportune collaboration, given the growing national and international alignment between cell and gene therapy and provided a unique opportunity to increase interactions between our Societies.

200 delegates attended the Meeting, with 8 international invited speakers, 64 oral presentations and 75 posters. The Organising Committee developed an excellent program. Sessions included those on gene therapy, vector development and gene editing, disease modelling, regenerative medicine and bioengineering, clinical translation and clinical trials, stem cells and system biology.

A special event at the Meeting was the ethics and policy organised by our Policy, Ethics and Translation Subcommittee: *First-in-Man Trials – Twists and turns on the road to translation*. This forum boasted distinguished panellists included Amit Nathwari (UCL), Eva Feldman (University of Michigan), Megan Donnell, Sanfilippo (Children's Foundation, Australia), Christopher Scott (Baylor College of Medicine) and Janet Macpherson (Royal Prince Alfred Hospital). Megan Munsie convened and chaired this well-received session that covered the perspectives of medical practitioners, researchers, bioethicists and patient advocates.

We again ran a Corporate Breakfast Session, this time on anti-cancer cellular immunotherapy and sourcing biological materials, which was extremely well attended.

As usual, the range and quality of the posters and presentations were outstanding. We congratulate the postgraduate/ECR winners of our Oral and Poster Prizes for their outstanding efforts:

#### **Organisation of the 2018 ISSCR Meeting**

ASSCR welcomes the international stem cell community to Melbourne for the ISSCR 2018 meeting from 20–23 June next year. As ASSCR President, I was invited to chair the scientific organising committee which also includes Professor Hans Cleavers, current President of ISSCR, and a geographically and scientifically diverse set of committee members who have worked hard to bring together and excellent scientific program. We are very proud to announce that eminent Australian embryologist and stem cell biologist, Professor Patrick Tam, will give the Anne McLaren lecture. Professor Jane Visvader has also been invited to present in the Cancer Stem Cells Plenary. The keynote address will be presented by Professor Jennifer Doudna discussing her breakthrough research on CRISPR gene editing. There will be 20 concurrent sessions throughout the meeting with each including 1 to 2 invited speakers with the rest being drawn from abstracts. Concurrent speakers from Australia will include Professor Andrew Elefanty (MCRI) and Dr Paul Simmons (Mesoblast). Abstracts open on 6 December, 2017.

The role of ASSCR has primarily been collecting the sponsorship pledges for the ISSCR bid from all organisations other than the Melbourne Convention Centre and the Victorian State Government. The Melbourne Convention Centre itself, together with the Stage Government, have provided close to \$600,000 towards the meeting while ASSCR, as the bid host, will collect in excess of \$330,000 to support the running of the event by the ISSCR. This will be completed by the second week of December and I will be present for the ISSCR Board meeting on December 1 to present a summary of income. The Society has had fabulous local support from Victoria Pope at the Melbourne Convention Centre and would also acknowledge the kind donations of all pledge sponsors, but would particularly highlight the contribution of \$60,000 from CSL as well as commitments of >\$25K each from Mesoblast, ASSCR and Stem Cells Australia.

### Strategy for Maintaining Large Numbers of ASSCR Conference Travel Awards

Alongside these joint conference opportunities there have been a number of challenges. The most significant of these has been a decrease in travel award funding received from the NSCFA to \$20,000 for the 2016 and 2017 conferences, which the ASSCR matched with \$20,000. This combined support enabled 64 Travel Awards to be provided for postgraduate students and ECRs, plus 2 international travel awards each year. Importantly, the Travel Awards were funded while still achieving strong growth in ASSCR cash reserves.

The Society greatly appreciates continued NSCFA support at whatever level possible. Nevertheless, with this large reduction in NSCFA support, the Society will continue to pursue strategies strongly encouraging attendance at our meetings by Postgraduate students and ECRs.

#### **ASSCR Public Engagement and State-Based Events**

Hot Topics Forum

Due to popular demand, the 4<sup>th</sup> Q&A Hot Topic: Clinical Trials – The Good, the Bad and the Ugly was held on 17 August 2017 at the Victor Chang Cardiac Research Institute and chaired by Margret Schuller. The panel and audience discussed controlled clinical trials compared to observational, evidence-based studies; the many important roles and responsibilities associated with human clinical trials; and the role of ethics and law, funding and regulation, the media, and responsibilities to patients, as well as patients' responsibility as participants in a clinical trial.

As in previous years, the feedback was positive, and delegates liked the diversity of the panel and the panel members' expertise. The event was free and of nominal cost for the Society, given that sponsorship was found (Bio-Strategy Laboratory Products and GE Healthcare Life Sciences). The summary of the panel discussion can be read on the ASSCR website. The events also provide an opportunity to recruit members.

Panel members included: Clinicians involved in stem cell clinical trials – Dr Ken Mickelwaite (Westmead Hospital) and A/Prof. James Wickham (Charles Sturt University); Biotech/translational researchers – Dr Kilian Kelly (Cynata) and Prof. John Rasko (Sydney University); Ethics/law specialists – Dr Tereza Hendl (Sydney University); Funding and regulatory specialists – Dr Tony Manderson (TGA) and Dr Tony Penna (Executive Director, the Office for Health and Medical Research); Reporters – Jill Margo (ABC AM; Health Editor, Financial Review); Patients – Dr James Wickham.

Submissions to the TGA on the regulation of autologous stem cell procedures

In March 2015, the ASSCR, under the leadership of the Policy, Ethics and Translations subcommittee, submitted its views to the TGA on potential changes to policy and practice regarding this contentious and, at present, less stringently regulated, clinical field. Our submission recommended tightening of controls in several key areas. The full report, along with those of similar Australian societies and networks, and various individuals can be found here.

In August 2016, the TGA announced a second round of consultation: <u>Regulation of Autologous</u> Cell and Tissue Products and Proposed Consequential Changes to the Classification of Biologicals

The ASSCR again made a submission maintaining a strong and consistent position on this issue. The timing of this second round was particularly relevant in light of the recent NSW Coroner's Inquest into a "Surgical case – "Experimental" therapy for dementia", as commented on by the ASSCR.

It is very pleasing to see that after these two consultations and many years of discussion, the TGA have taken positive steps towards curbing the growth of the unproven stem cell industry with the main points as follows:

- TGA will regulate all autologous cell and tissue products (both homologous and non-homologous use; manufactured and minimally manipulated) if they are offered *outside a hospital setting*.
- Where the cells are offered in an accredited hospital they will be excluded from TGA oversight.
- Practitioners have been broadened to include dentists as well as medical practitioners.
- Advertising of 'products' is banned but 'services' that do not mention specific products can still be advertised.
- Access to unapproved therapeutic goods is still available via clinical trials and the Special Access Scheme.
- Roll out of new regulations is to occur in early 2018.

Thank you to everyone (including our former President Michael O'Connor) for working towards resolving this issue.

#### **ASSCR Website and Communication with Members**

Over the past 2 years we have used a combination of direct emails and our <u>asscr.org</u> webpage to communicate with members and to promote activities. Both mechanisms have been very effective. Additionally, we have created a Twitter presence (@theASSCR), which we hope will grow to provide greater visibility.

To improve connection with Members, and to better share information with the community, we have invested in the development of a new webpage hosting service and are in the process of designing a new site. This new service will allow for greater flexibility and greater content. We anticipate having the site up and running before Christmas. The basics features that are on the existing site are already embedded into this new site. We are soliciting members for content. Specific information that we would like to include are: (1) Researcher Spotlights, including biographies, (2) Increased advertising of local events, (3) Patient information, and (4) stem-cell educational content. #### **ASSCR Finances**

As described in the Treasurer's Report, the Society is solvent and in a healthy financial condition. In keeping with previous years, revenue reported under the Society ABN for the 2016–17 financial year is below \$250,000 and thus the Society remains a small society as defined by the Australian Charities and Not-for-Profits Commission. To our knowledge the financial statements presented here, prepared in consultation with the ASN Events financial officer, provide a true and accurate description of the Society's finances. Through the success of our 2016 and 2017 joint meetings in the Margret River and Sydney our cash reserves have increased well, placing the Society in a good position to meet the challenges of the next 2 years, including the Society's current and future liabilities, with particular regard to ISSCR2018.

#### Improving Committee Position Descriptions, Timelines and Handover Documents

The Committee has completed the process of developing detailed position descriptions and timelines for all its positions and many of its activities including the holding of elections, the generation of the Annual Report, and annual Membership reminders. This, together with our Rules of Association, and the continued development of a business plan is helping to clarify roles and to improve information transfer to new Committee and Subcommittees members.

#### **2017 Committee Election Process**

This year nominations were called for 4 elected Committee positions: Treasurer, Secretary and the Chairs of the Sponsorship and Industry subcommittee and the Membership and Communication subcommittee.

Single valid nominations were received for the positions of Treasurer and Chairs. Therefore, as per ASSCR rules no election will be held for these positions. An online ballot is being held for the two nominations received for the position of Secretary. The results of the election will be announced at the 2017 Annual General Meeting to be held by teleconference at 11 AM – Midday on 11 December.

### **Summary**

ASSCR has had a very busy period of time over the past 12 months and faces a major year of activities around the ISSCR 2018 meeting. Our new committee members have shown incredible willingness to work on your behalf and great dedication to the development of researchers across the country in this space. As President, I am proud of the quality of the research being presented at our meetings and the pace at which we are embracing new research and clinical translation approaches.

I have enjoyed my first year as President and hope that I can bring the Society through the challenges of surviving through a year without an ASSCR meeting. The Society is at risk of reducing membership across this time given the lack of incentive to rejoin. I would strongly urge you to remain aligned to ASSCR across this time period to ensure that we have a robust society post ISSCR 2018. To this end, the Society will be working hard in the coming year to upgrade its website and communication lines with its members and will continue to support state-based activities wherever possible.

# **Committee Meeting Dates and Membership**

#### ASSCR Committee Meeting Dates and Attendance (July 2016–December 2017)

This has been the second full year of the Society's new Committee structure. Under this structure, the 9-member Committee has held 9 meetings, as listed in the Table below. The ASSCR and many of its Committee Members also held 10 joint meetings with the AGCTS to organise the 2017 Joint Meeting held at UTS, Sydney.

In addition, the Committee engaged in frequent email communication throughout the year, including on the following matters:

- (i) Contract finalization for the successful bid for 2018 ISSCR Conference. The Society has set up, with the help of ASN Events, a process for receiving pledges from pledging institutions and investing them in a term deposit prior to transfer to the ISSCR.
- (ii) The Society has also invested some of its other capital in a separate term deposit. Money raised from these investments will go to support various activities, including Travel Awards for local and international postgraduates and ECRs.
- (ii) Preparing for our 4<sup>th</sup> and 5<sup>th</sup> joint Annual Meetings (with the Centre for Cell Therapy and Regenerative Medicine in 2016 and the Australasian Gene and Cell Therapy Society in 2017).
- (iii) Providing the framework for awarding Postgraduate and Early Career Researcher Travel Awards for the 2016 and 2017 meetings, sponsored by the NSCFA and the ASSCR.
- (iv) Preparing for the ISSCR2018 meeting, including the format, timing and location of the ASSCR-run public forum.
- (v) Continued improvement to the new website with an expansion of the content of the eNewsletters, and the opening of our new Twitter account (@theASSCR).
- (vi) Making submission to the second TGA call for potential changes in regulations relating to autologous stem-cell procedures (October 2016).
- (vii) Policies have been developed to respond to public enquiries and to assess Membership applications.
- (viii) A registry is being developed of companies, clinicians and researchers working in the field of stem cells and regenerative medicine in the broadest context.



#### **Memberships**

ASN Events was contracted for a third 2-year period (starting July 2016) to process ASSCR Membership payments and renewals. This outsourcing allows volunteers to focus on issues relating to enhancing and expanding the reach of the Society and providing better service and opportunities to its Members. In a significant change, however, the ASSCR partnered with its joint-meeting societies in 2016 and 2017 to run the Annual Meetings largely without input from ASN Events. The anticipated savings should help to keep meeting registration costs low, provide Travel Awards to postgraduates and ECRs as the gratefully received NSCFA sponsorship diminishes, and support additional ASSCR-sponsored events.

As of 30 June 2017, the ASSCR had 246 financial Members, an increase of 20 over the last 2 years and a substantial increase over previous years (206 Members in 2014; 169 in 2013; 89 in 2012. The graph below shows the geographic distribution of our Members.

# Treasurer's Report, Financial Year 2016–17

The Australasian Society for Stem Cell Research (ASSCR) is incorporated in Victoria PC 3194 (ABN:45 374 899 784) and registered as a tax-exempt *not-for-profit* charitable organisation. As a Charitable Institution the society is endorsed to access the following tax concessions: GST Concession 18 Apr 2008<sup>1</sup>; Income Tax Exemption (since 18 Apr 2008); and FBT Rebate (since 18 Apr 2008). The ASSCR is also endorsed as a Deductible Gift Recipient (since 18 Apr 2008).

Cash Flows were previously managed through a BankWest business account but this has been inactive since 2013. The remaining funds in this account will be incorporated into a longer-term investment strategy that was initiated by ASSCR with the establishment of a \$50,000 Term Deposit Account. The ASSCR had cash reserves of approximately \$138,987 at the end of the 2016-2017 Financial Year.

ASSCR Annual Meetings have been managed by ASN Events since 2008. In 2012 we signed a memorandum of understanding with ASN for secretariat services. Cash flows associated with membership fees, conferences and other activities are managed by ASN via an Operating Account held at National Australia Bank (NAB). The ASSCR Committee members are not signatories to this account; instead the Treasurer and ASSCR President authorize the ASN Financial Controller to make and receive payments.

All transactions processed via ASN are reported to the Australian Taxation Office (ATO) by ASN Conferences acting as agent, and all GST liabilities are remitted by ASN Conferences on submission of the ASN Conferences Business Activity Statements (BAS). Currently all GST reporting occurs under the ASN Events' ABN; moreover ASSCR submits 'nil GST returns' to the ATO with respect to its own ABN (as no transactions occur outside of the ASN-operated NAB account). ASN provides the ASSCR with a quarterly tax liability summary as well as a full GST ledger annually for our records.

<u>Income</u> this financial year was generated by a combination of membership fees, profit share from the 2016 Annual Meeting, sponsorship, and interest earned on our bank accounts. <u>Expenditures</u> this financial year were student/ECR travel awards (for both 2016 and 2017 Annual Meetings), ISSCR 2018 Meeting pledge, 2017 Annual Meeting seed funds, secretariat fees, website, and committee teleconferences (see the notes to Table 2 for more details).

Breakdowns of Income and Expenditure as well as Net Equity for each year from 2014-2017 are provided in Table 2 for comparison purposes. A brief summary of our financial position as of 30<sup>th</sup> June 2017 (including financial summary of the 2016 Annual Meeting) is given below.

#### **ASSCR Net Equity:**

As of June 30th 2017, our net equity was \$138,986.34. This sum included:

- a) \$17,665.40 in our Bankwest account
- b) \$121,320.94 in our ASN managed NAB accounts (Operating and Term Deposit)

#### Note on tables:

**Table 2:** Accounting is performed differently for the joint society meetings (i.e. 2014, 2015, 2016) than for standalone ASSCR meetings (2013). For simplicity, income from joint meetings is presented as ASSCR's profit share less any ASSCR-specific expenses or income. All values have been rounded to the nearest dollar.

<u>ASSCR Income</u> in the 2016-2017 financial year (independent of 2016 and 2017 Annual Meeting income) came from memberships, interest on our operating and term deposit accounts, and sponsorship (see below).

\* The \$20,000 sponsorship payment was provided by NSCFA to support student/ECR travel awards for both the 2016 and the 2017 Annual Meetings.

ASSCR had also collected \$52,500 in pledges for the ISSCR 2018 Meeting that were held in our ASSCR accounts at the end of the 2016-2017 financial year. This amount is <u>not included</u> in the Income Statement (Table 2) or the Net Equity calculation (Table 3).

ASSCR expenses in the 2016-2017 financial year (independent of 2016 and 2017 Annual Meeting expenses) were secretariat fees (administration and accounting), web site maintenance, committee phone meetings, travel awards to support attendance of student and ECR members at the 2016 and the 2017 ASSCR Annual Meetings, and pledged/paid support for the ISSCR 2018 Meeting (see below).

Travel award payments (\$21,924) were made to students/ECRs attending the 2016 and the 2017 Annual Meetings. This amount represents the portion of the travel award budget that was paid directly to awardees as flight/travel reimbursement within the 2016-2017 financial year (not all reimbursements were reconciled by June 30<sup>th</sup>). It does not include additional award items (conference dinner tickets and complimentary memberships). ASSCR pledged partial matching funds (~\$7,000 per meeting) to fund these additional award items.

ASSCR pledged \$20,000 in support of the bid for Melbourne to host the ISSCR 2018 Meeting. This amount was paid to ISSCR this financial year along with other pledges collected by ASSCR on behalf of ISSCR.

\*\*\*\*General ASSCR expenses (\$7,888) included ASN management fees, accounting, teleconferences, and bank fees.

Seed funding (\$7,000) provided in support of the ASSCR/AGCTS 2017 Joint Meeting will be returned prior to calculation of profit share in the next financial year.

- The strategy has allowed us to be increasingly solvent and commit \$20k to ISSCR, put on public events, etc.
- MOC secured \$20k sponsorship from NSCFA for Travel Awards for this year and next year. This has been supplemented by \$17k from the ASSCR + \$4k for this year and next year for international delegates.
- This has been critical in bringing Postgrads and ECRs to our meetings exposing them to the benefits of

- It also means our meetings attract a lot of abstracts particularly from ECRs and we really can choose fantastic work for oral presentations.
