President's Report: January-November 2020

The beginning of this year saw us looking forward to hosting our annual conference in Melbourne, with plans for a program to promote presentations by early career researchers and for foster networking opportunities. Despite the intervention of the SARS-2 Coronavirus, which ultimately led to the cancellation of our annual scientific meeting, these ideals remain a focus for the society going forward. Like much of the country, our plans have been put on hold as we await the return of better times. In recognition of this holding pattern, the ASCCR committee extended the memberships of all current members for 12 months at no cost to ensure stem cell researchers still had a point of contact with their community.

The break from our usual focus on organising the annual conference has provided us time to reflect on how the society engages with its members. Going forward, next year will see the society sponsoring smaller regionally focused gatherings that showcase the work of new investigators, with a view to providing a platform for the presentation of science and for networking. We hope to kick off this initiative with a locally organised meeting in Brisbane early next year – details will be announced over coming months. We envisage similar society sponsored gatherings or meetings will be held across Australia and New Zealand prior to our major Annual meeting late next year. Members who are interested in contributing to organising or hosting such meetings are encouraged to reach out to our committee.

The society has been very fortunate to benefit from a new partnership with Professor Christine Wells' *Centre for Stem Cell Systems*, which has been running a locally focussed Zoom forum "*Stem Cell Conversations*". This highly accessible format includes 2 short presentations and Q and A in a regular 30-minute timeslot. Professor Wells has generously allowed the ASSCR to piggyback on the success of this forum, enabling the society to host a national version of the event on a monthly basis. We hope this idea will continue after the COVID-19 has gone, providing an avenue to connect people between conferences and meetings on an ongoing basis.

This year has also seen the ASSCR become a member of the <u>Science and Technology Australia</u>, a national organisation representing more than 80,000 Australians engaged in science and science based industries. The ASSCR's association with STA has been further strengthened by the appointment of Professor Megan Munsie, current chair of our Policy, Ethics and Translation sub-committee, to STA's STEM sector policy committee. We congratulate Megan on this appointment that will help provide a voice for stem cell researchers through the STA's public and government focussed advocacy activities.

On the funding front, the society was pleased to see that a number of its members received grants from the MRFF Stem Cell Mission to support stem cell related projects spanning discovery science to clinical applications. In all, \$5.9M was awarded to 8 projects related to Parkinson's Disease, epilepsy, muscle and skin repair, autoimmune disease, macular degeneration, fatty liver disease and leukaemia. ASSCR members have also received funding to bring stem cell technology to bear on Australia's COVID-19 research effort, both as a source of human cells to study effects of SARS-2 virus on different tissue types and for testing existing drugs for anti-COVID-19 activities. The involvement of our members in contributing to this effort is a timely reminder that research can have unanticipated applications and why it is important to maintain a healthy and active scientific community.

Continuing from last year, the ASSCR has formed closer ties with the <u>NSCFA</u>, a philanthropic organisation whose mission is to support and promote stem cell research in Australia. We are grateful to the NSCFA for supporting the attendance of students and early career researchers at our conference last year and pleased the society will continue its commitment to hosting <u>Metcalf prize</u> winners at future ASSCR annual conferences.

Our AGM will be held as a teleconference on 15th of December, at 2.00 PM, with attendance details to be provided. As the holding of an AGM is a legal requirement for the Society and the meeting must be quorate for voting to occur, it is imperative that members to make an effort to attend.

Finally, this is my last year as President and I would like to pay tribute to the great individuals that make up the ASSCR committee. It has been a pleasure and privilege to work with all of you and I sincerely thank you for keeping me and the society heading in the right direction. With Prof. Helen Abud taking over as President next year, I am certain the society will continue to be a valuable contributor the nation's research landscape.

ASSCR Finances

As described in the Treasurer's Report, the Society is solvent and in a healthy financial condition. In keeping with previous years, revenue reported under the Society ABN for the 2019-20 financial year is below \$250,000 and thus the Society remains a small society as defined by the Australian Charities and Not-for-Profits Commission. To our knowledge the financial statements presented here, prepared in consultation with the ASN Events financial officer, provide a true and accurate description of the Society's finances.

2020 Committee Election Process

This year nominations were called for 4 elected Committee positions: Vice President, Policy and Translation/Ethics/Public Policy/Clinical Translation subcommittee, Professional Development and Junior Investigators subcommittee, Conference and Awards subcommittee. Single valid nominations were received for each of the four positions. Therefore, as per ASSCR rules no election will be held for these positions. The results of the election will be announced at the 2020 Annual General Meeting to be held via Zoom on Tuesday the 15th of December, at 2.00 PM Australian Eastern Daylight Time.

2020 is certainly going to be a year that will be remembered. Despite the tribulations visited upon us by an unwelcome virus, the society is in great shape and looking forward to becoming increasingly active in years to come. 
Memberships

Treasurers Report, Financial Year 2019-2020

The Australasian Society for Stem Cell Research (ASSCR) is incorporated in Victoria PC 3194 (ABN:45 374 899 784) and registered as a tax-exempt not-for-profit charitable organisation. As a Charitable Institution the society is endorsed to access the following tax concessions: GST Concession 18 Apr 2008; Income Tax Exemption (since 18 Apr 2008); and FBT Rebate (since 18 Apr 2008). The ASSCR is also endorsed as a Deductible Gift Recipient (since 18 Apr 2008).

Cash Flows are managed through a National Australia Bank (NAB) Operating account. The Society held one Term Deposit account in this financial year (at NAB). The ASSCR had cash reserves of approximately \$151,958 at the end of the 2019-2020 Financial Year.

In 2012, we signed a memorandum of understanding with ASN for secretariat services. Cash flows associated with membership fees, conferences and other activities are managed by ASN via the NAB Operating Account. The ASSCR Committee members are not signatories to any of the accounts; instead the Treasurer and 2 elected committee members authorize the ASN Financial Controller to make and receive payments.

All transactions processed via ASN are reported to the Australian Taxation Office (ATO) by ASN Conferences acting as agent, and all GST liabilities are remitted by ASN Conferences on submission of the ASN Conferences Business Activity Statements (BAS). Currently all GST reporting occurs under the ASN Events' ABN; moreover, ASSCR submits 'nil GST returns' to the ATO with respect to its own ABN (as no transactions occur outside of the ASN-operated NAB account). ASN provides the ASSCR with a quarterly tax liability summary as well as a full GST ledger annually for our records.

Income this financial year was generated by a combination of membership fees, sponsorship, and interest earned on our bank accounts. Expenditures this financial year were Sponsorship, Prizes and Awards, administration and consultancy fees, website, and committee teleconferences (see the notes to Table 1 for more details).

Breakdowns of Income and Expenditure as well as Net Equity for each year from 2017-2020 are provided in Table 2 for comparison purposes. A brief summary of our financial position as of 30th June 2020 is given below.

ASSCR Net Equity:

As of June 30th 2020, our net equity was \$151,982.39. This sum included:

2019 ASSCR-ACGTS-ISCT ANZ joint meeting (Brisbane):

• All expenditures and income have now been reconciled; the meeting account has been closed and the ASSCR's profit share from the joint meeting distributed back to our operating account (funds received March 2020).

Total Meeting Income: \$ 150,647.78

Total Meeting Expenses: \$ 133,422.13

Net Trading Position (surplus): \$ 17,225.65

ASSCR Profit Share: \$ 5,741.89

An agreement to share the profit evenly across the societies was negotiated between the ASSCR executive committee, ISCT-ANZ and ACGTS, and approved by the Society Presidents and Treasurers. The profit share for this meeting was reconciled in March 2020.

Table 1: Accounting is performed differently for the joint society meetings (2016, 2017, 2019). For simplicity, income from the joint meetings is presented as ASSCR's profit share less any ASSCR-specific expenses and/or income. All values are rounded to the nearest dollar.

ASSCR Income in the 2019-2020 financial year came from memberships, interest on our operating and term deposit accounts, and sponsorship.

* Due to the ISSCR in Melbourne in 2018, ASSCR did not host a meeting in the 2018-2019 financial year hence no associated profit/loss is reflected in Table 1 for this meeting.

**Interest and other income includes: (i) \$1807 in combined interest from the ASSCR operating account and term deposit, (ii) a reimbursement of \$2947.75 from NSCFA for their support of the public forum associated with the joint meeting in Brisbane and the travel expenses for Metcalf awardees to attend the meeting, (iii) donation (\$62).

*** \$20,000 sponsorship payment was provided by NSCFA for Travel awards to support Australian ASSCR members to attend the 2019 joint Annual Meeting in Brisbane.

ASSCR expenses in the 2019-2020 financial year were: travel awards to support attendance of student/ ECR members at the 2018 ISSCR meeting, secretariat fees (administration and accounting), web site maintenance, and committee phone meetings (see below).

**# A \$36,735 sponsorship payment was provided by NSCFA for Travel awards to support ASSCR members to attend the 2018 ISSCR Annual Meeting in Melbourne. These funds were received in the 2017-2018 financial year, with reimbursement of these awards made after the meeting, paid in July 2018. ASSCR provided an additional \$2400 to support 2 NZ ECR travel awards, collectively totalling \$39,135 and covering a total of 66 travel
