President's Report: January-November 2022

The year commenced with the majority of our interactions with colleagues still via zoom with some uncertainty as to when we might emerge from the COVID-19 pandemic and reconnect with our scientific community again. With a new wave of COVID, we made the difficult decision to postpone our annual meeting again from March until 16th to 18th November 2022 at Melbourne Connect. As the year has progressed there has been considerable anticipation and enthusiasm for our upcoming meeting and many planning meetings with the Australasian Gene and Cell Therapy Society (AGCTS). We have numerous high-profile international speakers, some who will join in person and others virtually. There is also an impressive selection of national speakers attending and presentations selected from submitted abstracts. With support from the National Stem Cell Foundation of Australia (NSCFA) we have managed to award over 40 travel grants to students and ECRs to attend the meeting. We had a larger number of abstracts submitted than we anticipated, alongside many sponsors eager to interact with scientists again, so we had to more than double the space we initially had booked. We did not like the idea of having to turn anyone away so we are looking forward to a stimulating meeting with many sponsors, exhibitors, scientific breakfast sessions and vibrant poster sessions. This will be a wonderful opportunity for members to network, build links and catch up with friends and colleagues. There is great excitement to re-engage and share our science in person.

The enthusiasm of our early and mid-career researcher continues to promote activity and further local meetings supporting networking and showcasing of the work of our early career researchers are planned in Western Australia and New Zealand. These meetings are primarily driven by the society's ECR committee alongside local organisers. This builds on the success of meetings held in Melbourne, Brisbane and Sydney in 2021 and we plan to continue support for this model. We encourage members who are interested in contributing to organising or hosting such meetings in their city to reach out to our committee. The talent of our early and mid-career researchers is truly inspiring.

We have also been thrilled to continue our partnership with Professor Christine Wells and colleagues from across the Parkville stem cell community, running a nationally focussed monthly Zoom forum as part of their highly successful "*Stem Cell Conversations*" series. These sessions are also coordinated by our talented ECRs and we also utilised this forum to hold our 2022 ASSCR ECR Awards Symposia, where the award-winning presentations from our 2021 ECR symposia in Victoria, NSW and QLD were highlighted. These sessions have continued to be popular in attracting audiences and we thank Professor Wells and her colleagues for their generosity in facilitating the success of this forum. We plan to continue this highly successful program in 2023.

We were delighted to see our past president Professor Melissa Little complete her term as president of the International Society for Stem Cell Research (ISSCR). The ISSCR promotes responsible stem cell research to advance knowledge and stem cell treatments and represents 4000 members globally. We congratulate Professor Little for her outstanding leadership. Many Australian stem cell researchers had the opportunity to present their work in person at the 2022 ISSCR annual meeting in San Francisco. Congratulations to Megan Munsie, Jose Polo, Sara Howden, Michal Stumpf, Jessica Vanslambrouck, Vaibhao Janbandhu, Sophie Shen and Nadia Rajab.

The society was pleased to see stem cell researchers receive awards for their exceptional achievements. This includes Pengyi Yang and Siok Tey, the Metcalf award winners, Megan Munsie for being highly commended for the Advocacy Award, Research Australia, Melissa Little for the Marshall and Warren Ideas Grant Award and Xiaodong Li for winning the Victorian Premier's Award for Health and Medical Research. It was also wonderful to see the establishment of reNEW, a partnership between University of Copenhagen, Denmark, Murdoch Children's Research Institute, Australia, and Leiden University Medical Center, the Netherlands. This initiative, led by Professor Melissa Little is funded by the Novo Nordisk Foundation to support the translation of stem cell discoveries and is an enormous boost to the field. There were also many outstanding publications from stem cell researchers in 2022. We congratulate our members on their success in fellowships and grant funding, especially from the MRFF Stem Cell Mission where a broad range of projects were funded. The breadth of research involving our members and the potential impact continues to be impressive.

The ASSCR continues collaboration with the National Stem Cell Foundation of Australia (NSCFA), a philanthropic organisation whose mission is to support and promote stem cell research in Australia. NSCFA continues to support travel awards for students and ECRs from around the country to attend our annual meeting and are supporting a public forum to be held on the evening of November 15th just prior to our annual meeting. We are pleased to host the Metcalf prize winners and researchers from their Matched Funding program at our annual conference. We are extremely grateful to the NSCFA for their ongoing support.

This year we have introduced a new award, the Rising Star award to provide further recognition for our early career researchers. The inaugural winners will be announced in the final session of our 2022 Annual Conference. We thank the committee members and past presidents who judged the applications and the additional support enthusiastically provided by the NSCFA. I am delighted to announce that in 2023 the ASSCR will introduce two new awards to recognised the contribution of our members, the ASSCR President's Award for outstanding career achievement and inspiring leadership and the ASSCR Game Changer Award to recognise ideas and contributions that have transformed the field or



contributed significantly to the community. Details of the award guidelines and application process are attached on Appendix 2.

Four key members of the ASSCR committee are finishing this year, Dr Nathan Palpant, Policy, Ethics and Translation, Dr Margret Schuller, Sponsorship/Fundraising/Industry, Dr Shiang (Max) Lim, Conference and Awards and Dr Jarmon Lee, Professional Development and Junior Investigators. I would like to pay tribute to the key contributions they have made to the committee. ASSCR Communication with members

The ASSCR committee communicates directly with members through e-mail, and with the broader community through its website (asscr.org) and social media profiles (Twitter, new handle: @theASSCR). These communications platforms are used to share information about upcoming events, research and news articles relevant to stem cell science and regulation, to announce awards and publications, share photographs, and run social media campaigns. The ASSCR website (asscr.org) continues to provide information regarding the society, links to educational material for patients and the general public, advertises events such as workshops, seminars, public events, and conferences, advertises jobs and scholarships, contact forms, and snapshots of recent social media posts. The material disseminated by the ASSCR is reliant on submissions from ASSCR members, as well as associated groups. Material relevant to stem cell research or regulation is welcome from members of ASSCR and affiliates.

This year, the ASSCR will hold its Annual General Meeting in person at the 15th Annual ASSCR Conference, main Auditorium on **Thursday 17 of November at 5:30-6:00pm** (**AEDT**). As the holding of an AGM is a legal requirement for the Society and the meeting must be quorate for voting to occur, it is imperative that members make every effort to attend. Members of our society were invited to attend the AGM by email.

ASSCR's National Stem Cell Conversations

The ASSCR's "*National Stem Cell Conversations*" is now in its 3rd year and has hosted over 50 invited speakers from across Australia and overseas, bringing the stem cell community the very latest research. Held in collaboration with Professor Christine Wells and the Parkville stem cell research community, the series has been regularly attended by 50-70 persons from across Australia and provides an easily accessible forum to stay connected and engage in conversation. The National Stem Cell Conversations are moderated by Dr Jarmon Lees, Dr Marina Naval Sanchez, and we have recently welcomed Dr Osvaldo Contreras as a third moderator earlier this year. ASSCR's ECR Award Symposium

Spanning two sessions across March and April 2022, the ASSCR held an online event showcasing the award-winning presentations from our 2021 ASSCR ECR symposia to a national audience. Featuring 10 ECRs from across VIC, NSW and QLD, the sessions were attended by almost 200 people, allowing us to showcase the exciting research being conducted by the future leaders of the stem cell community.

ASSCR Finances

As described in the Treasurer's Report, the Society is solvent and in a healthy financial condition. In keeping with previous years, revenue reported under the Society ABN for the 2020-21 financial year is below \$250,000 and thus the Society remains a small society as defined by the Australian Charities and Not-for-Profits Commission. To our knowledge the financial statements presented here, prepared in consultation with the ASN Events financial officer, provide a true and accurate description of the Society's finances.

2022 Committee Election Process

This year nominations were called for four elected Committee positions: the Policy and Translation/Ethics/Public Policy/Clinical Translation Chair; the Professional Development and Junior Investigators Chair; the Conference and Awards Chair; the Sponsorship/Fundraising/Industry Chair. Single valid nominations were received for the four positions. Therefore, as per ASSCR rules no elections were held for these positions. An election will be held for the position of Treasurer and Secretary in 2023. The results of the election will be announced at the ASSCR/ASGCT Annual Conference main Auditorium on **Thursday 17 of November at 5:30-6:00pm (AEDT).**

2022 is a year where we are re-connecting with colleagues and we expect our annual meeting to be a highlight for members. We have learnt of new ways to communicate during the pandemic and plan to retain the highly successful local ECR events and virtual "Stem Cell Conversations" initiated during this time. 
Memberships

ASN Events continues to serve as a contractor to process ASSCR Membership payments and renewals. As of October 2022, the ASSCR consisted of 262 members (Victoria 128, New South Wales 60, Queensland 35, Western Australia 12, New Zealand 8, International 8, Australian Capital Territory 5, South Australia 5, Tasmania 1).



Out of these 97 were student memberships, 11 were associate memberships and 146 were full memberships.

Please note that due to the COVID-19 crisis and the absence of the society's annual meetings in 2020, 2021 and first part of 2022 all memberships were extended by 12 months in each of these years (i.e. 36 months collectively) free of charge.

Treasurers Report, Financial Year 2021-2022

The Australasian Society for Stem Cell Research (ASSCR) is incorporated in Victoria PC 3194 (ABN:45 374 899 784) and registered as a tax-exempt not-for-profit charitable organisation. As a Charitable Institution the society is endorsed to access the following tax concessions: GST Concession 18 Apr 2008; Income Tax Exemption (since 18 Apr 2008); and FBT Rebate (since 18 Apr 2008). The ASSCR is also endorsed as a Deductible Gift Recipient (since 18 Apr 2008).

Cash Flows are managed through a National Australia Bank (NAB) Operating account. The Society held one Term Deposit account in this financial year (at NAB). The ASSCR had cash reserves of approximately \$151,651 at the end of the 2021-2022 Financial Year.

In 2012, we signed a memorandum of understanding with ASN for secretariat services. Cash flows associated with membership fees, conferences and other activities are managed by ASN via the NAB Operating Account. The ASSCR Committee members are not signatories to any of the accounts; instead the Treasurer and 2 elected committee members authorize the ASN Financial Controller to make and receive payments.

All transactions processed via ASN are reported to the Australian Taxation Office (ATO) by ASN Conferences acting as agent, and all GST liabilities are remitted by ASN Conferences on submission of the ASN Conferences Business Activity Statements (BAS). Currently all GST reporting occurs under the ASN Events' ABN; moreover, ASSCR submits 'nil GST returns' to the ATO with respect to its own ABN (as no transactions occur outside of the ASN-operated NAB account). ASN provides the ASSCR with a quarterly tax liability summary as well as a full GST ledger annually for our records.

Income this financial year was generated by a combination of membership fees, delegate registration fees, sponsorship and interest earned on our bank accounts. Expenditures this financial year were Prizes and Awards, administration and consultancy fees, website, and committee teleconferences (see the notes to Table 1 for more details).

Breakdowns of Income and Expenditure as well as Net Equity for each year from 2019-2022 are provided in Table1 and 2 for comparison purposes. A brief summary of our financial position as of 30th June 2022 is given below.

ASSCR Net Equity:

As of June 30th 2022, our net equity was **\$151,651.01**. This sum included:

- \$ 100,151.50 in our ASN managed NAB Term Deposit
- \$ 51,615.44 in our ASN managed NAB Operating account

Table 1: Accounting is performed differently for the joint society meetings (2017 and 2019). For simplicity, income from the joint meetings is presented as ASSCR's profit share less any ASSCR-specific expenses and/or income. All values are rounded to the nearest dollar.

ASSCR Income in the 2021-2022 financial year came from memberships, interest on our operating and term deposit accounts, and sponsorship.

* Due to the ISSCR in Melbourne in 2018, ASSCR did not host a meeting in the 2018-2019 financial year hence no associated profit/loss is reflected in Table 1 for this meeting.

**Due to COVID-19, the joint ASSCR annual meeting scheduled for March 2022 in Melbourne was postponed until November 2022 (FY22-23)

*** Interest and other income included \$600 ECR symposia registrations, and \$515.03 in interest on our term deposit and operating account.

ASSCR expenses in the 2021-2022 financial year were: ECR symposia awards, administration and accounting fees, web site maintenance, committee phone meetings and membership subscription (see below).

[#] A \$36,735 sponsorship payment was provided by NSCFA for Travel awards to support ASSCR members to attend the 2018 ISSCR Annual Meeting in Melbourne. These funds were received in the 2017-2018 financial year, with reimbursement of these awards made after the meeting, paid in July 2018. ASSCR provided an additional \$2400 to support 2 NZ ECR travel awards, collectively totalling \$39,135 and covering a total of 66 travel grants. This is collectively reflected in the profit (\$43,718) for the 2017-2018, balanced against the loss (-\$36,984) in the subsequent 2018-2019 financial year.

The Rising Star Award aims to recognize distinguished contributions of ASSCR members who have demonstrated excellence in research and leadership in the early stages of their careers. The award will be instigated in 2022 and two awards will be given each year.

Eligibility Requirements

To be eligible for a Rising Star Award the applicant must be:

- 0-5 years post-PhD or equivalent of full-time in the case of significant career interruption on the closing date of the year of application.
- a current member of ASSCR and held membership for at least 1 year.
- Applicants can either self-nominate or be nominated by a current ASSCR member.

Ineligible Applicants

- Previous ASSCR Rising Star Award winners are not eligible to apply.
- Applications that do not provide all the required information will be ineligible.

Awards

- Two awards will be presented each year.
- Each award winner will receive \$5,500 in prize money (inclusive of \$5,000 international travel grant provided by National Stem Cell Foundation), a certificate and free registration for the next ASSCR Annual Meeting.
